



PART 1 - INTRODUCTORY PROVISIONS

Short title

- 1.1** This regulation may be cited as the Emergency Preparedness Offences Amending Regulation.

Application

- 1.2** This regulation makes amendments to the Compliance Notice and Ticket Regulation.

Definitions

- 1.3** In this regulation,

“Compliance Notice and Ticket Regulation” means the Compliance Notice and Ticket Regulation YFNR 42/2017.
