#### PART 1 - INTRODUCTORY PROVISIONS

#### **Short title**

1.1 This Act may be cited as the Annual Budget Act, 2020 - 2021 Amendment Act No. 1.

# **Executive oversight**

1.2 The member of the Executive holding the Finance Portfolio is responsible for the executive oversight of this Act.

#### Authority and application

- 1.3 (a) This Act is enacted under
  - (i) 13.11.1 d. of Chapter 13 Governance of the Maa-nulth Treaty,
  - (ii) section 3.2(b) and (gg) of the Constitution, and
  - (iii) section 4.4(c) of the Financial Administration Act.
  - (b) This Act applies to expenditures made by the Yuulu?il?ath government under the Annual Budget Act, 2020-2021.

#### **Definitions**

1.4 In this Act,

"Budget Act" means the Annual Budget Act, 2020 – 2021.

#### **PART 2 - BUDGET AMENDMENT**

# 2020 - 2021 annual budget amendment

2.1 Schedule 1 to the Budget Act is amended by repealing the applicable expenditure set out in the applicable line item in that Schedule and replacing it with the applicable expenditure set out in the applicable line item in Schedule 1 to this Act.

# Commencement

**3.1** This Act comes into force on the date it is enacted.
