Short title

- 1.1** This regulation may be cited as the Park Harvesting Documentation Amending Regulation.

Application

- 1.2** This regulation makes amendments to the Wildlife and Migratory Birds Regulation.

Definitions

- 1.3** In this regulation

PART 2 - REGULATION AMENDMENTS

Wildlife and Migratory Birds Regulation amendments

2.1 The Wildlife and Migratory Birds Regulation is amended as follows:

- (a) by adding the following after section 3.1(b) as subsection 3.1(b.1):

“The applicable form in Schedule 1 is prescribed for the purposes of subsection 2.4(a) of the Act for making an application for Yuulu?il?ath park harvesting documentation.”;

- (b) by repealing the list of Forms set out in “SCHEDULE 1 – APPLICATION FORMS” and substituting the following:

“RH-1 – Yuulu?il?ath Harvesting Documentation Application

RH-2 – [Moved to YFNR 5/2011]

RH-3 – Yuulu?il?ath Hunting Documentation Application

RH-4 – Yuulu?il?ath Park Gathering Application

RH-5 – Youth Yuulu?il?ath Harvesting Documentation Application

RH-6 – Notification of Intent to Harvest Renewable Resources in the Pacific Rim National Park Reserve”; and

- (c) by adding Appendix 1 to this regulation as Form RH-6 at the end of Schedule 1 of the Wildlife and Migratory Birds Regulation titled “SCHEDULE 1 – APPLICATION FORMS”.

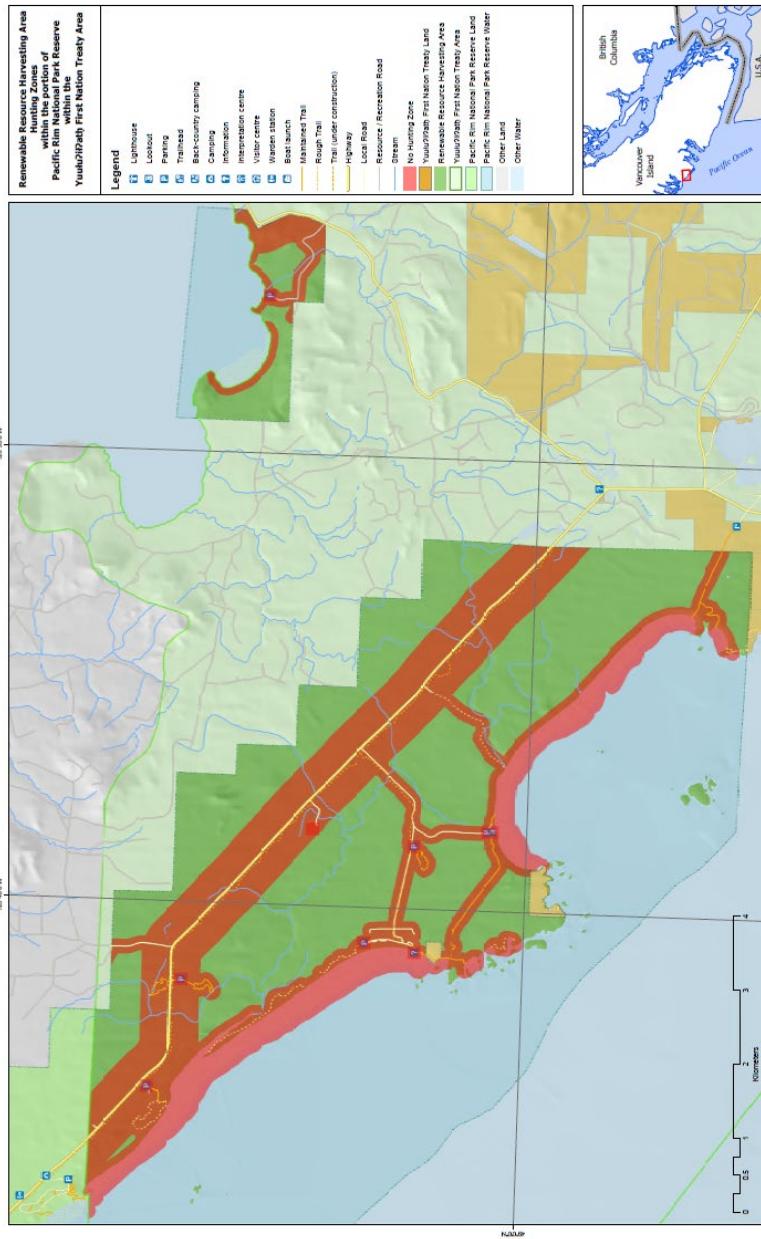

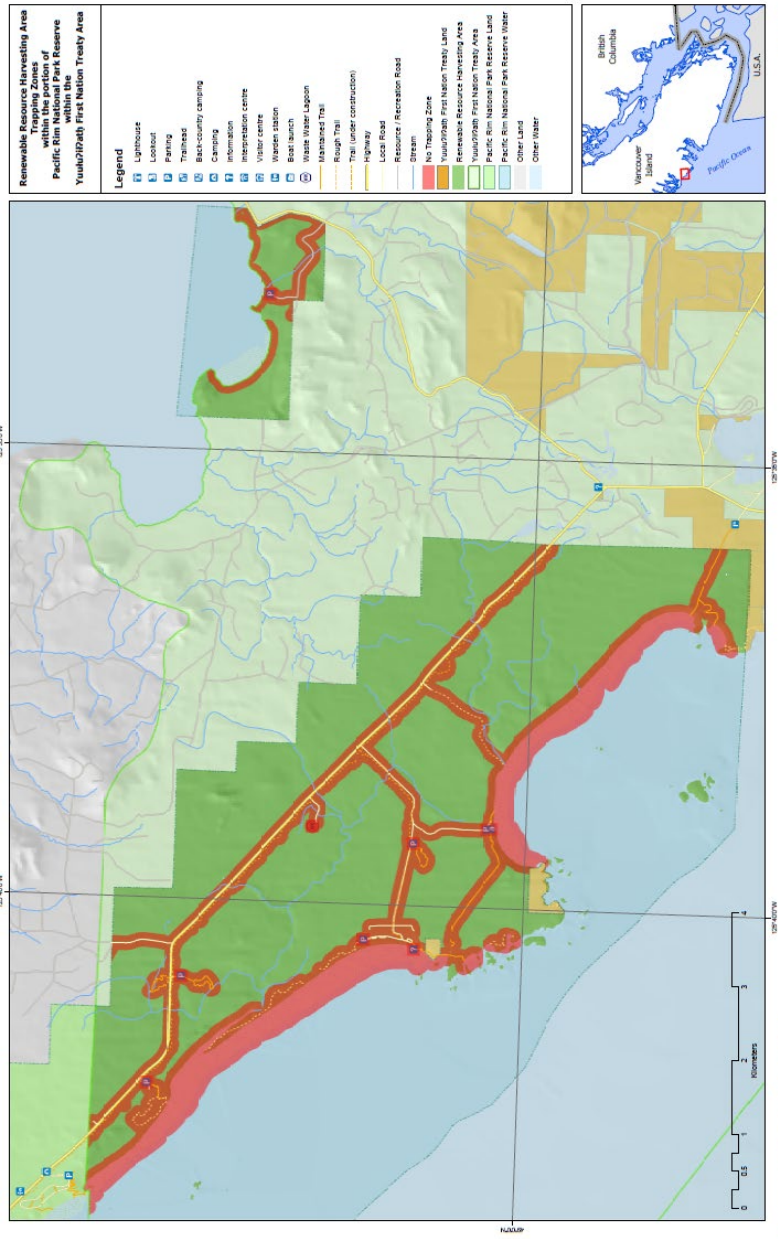
