

PART 1 - INTRODUCTORY PROVISIONS

Short title

1.1 This regulation may be cited as the Covid-19 Offences Amending Regulation.

Application

1.2 This regulation makes amendments to the Compliance Notice and Ticket Regulation.

Definitions

1.3 In this regulation,

“Compliance Notice and Ticket Regulation” means the Compliance Notice and Ticket Regulation, YFNR 42/2017.
