4. Executive Reports

Presentation of Draft Annual Budget 2023/24

Chief Financial Officer, Tamara Nelson, presented the draft 2023-2024 Annual Budget, including a PowerPoint presentation. The Director of Operations outlined the budgeting process that has occurred to date. The Chairperson asked if the housing and infrastructure budget includes repairs, to which the CFO confirmed that there are funds dedicated to repairs in the departmental budget. The Chairperson asked if there is anything in this budget to assist citizens with travel related to medical emergencies, to which the CFO confirmed that patient travel is funded through NTC and the fuel supplement covers current gas rates. In addition, a meal supplement is provided through NTC, and hotel coverage is provided on a case-by-case basis.
